

Mural Proposal

The artwork I am proposing would measure 8' tall and 24' long. It would be painted on (6) 4' x 8' 3/4" sheets of MDO ("signboard"). The paint used would be an exterior grade acrylic, and two types of sealant would be applied: an isolation coat and a UV-inhibiting varnish. Installation would be up to the city, so that cost is not included in my proposal.

The design would feature the city's name over the train trestle landmark. The founding date is on the upper left and a motto is on the upper right. Behind the trestle would be a colorful sunrise reflecting on the river below. Historic photos of the area are represented and will be painted in the colors of the original photos. There will also be a map in color, with White Cloud located in the center. The background will have the colors of three seasons: the trees on the left will be green, the trees on the right will have fall colors, and the lower right area will have snow.

There will be a female hiker and a male snowmobiler.

The cost for the artwork as proposed is based on current market prices for paint and lumber, and will be valid for 60 days. A down payment of 30% is required prior to starting the work. The total cost for the artwork is \$7,950.00.
